

## Official Rules for the Direct Auto Insurance

### 2019 Direct's Gobbler Giveaway Sweepstakes – Social (the "Sweepstakes")

**NO QUOTE OR PURCHASE NECESSARY. A QUOTE OR PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

- 1. Eligibility:** The Sweepstakes is open only to legal residents of Alabama, Arkansas, Florida, Georgia, Mississippi, North Carolina, South Carolina, Tennessee, Texas, and Virginia who are at least eighteen (18) years old at the time of entry. Void where prohibited by law. Employees of Direct Administration, Inc. ("Sponsor") and its affiliates, as well as the immediate family (spouse, parents, siblings, and children) and household members of those employees (i.e., people who share the same residence at least three (3) months out of the year, whether or not related), are not eligible to enter. An individual may win a Contest or Sweepstakes sponsored by Sponsor only once per six (6) month period unless otherwise specifically stated.
- 2. Entry Period:** The Sweepstakes begins at 12:00 AM Central Time Zone on November 1, 2019 and ends at 11:59 PM Central Time Zone on November 12, 2019 (the "Entry Period"). Entries submitted before or after the Entry Period will not be eligible. Sponsor's computer is the official time-keeping device for the Sweepstakes.
- 3. How to Enter:** Sponsor's Facebook, Instagram and Twitter Ad will invite individuals to follow the link to and complete the Sweepstakes entry form by providing your name, address, and email. There is a limit of one (1) entry per person regardless of social media platform and you may not use multiple e-mail addresses to enter. The use of an agency or any automated system to enter is prohibited, and Sponsor reserves the right to disqualify any entries received through such methods. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. All entry information becomes the sole and exclusive property of the Sponsor.
- 4. Drawings:** On or about November 13, 2019, Sponsor will select or cause to be selected at random two (2) potential winners from all valid entries received. The Winners will be notified by the email provided. The odds of winning depend on the number of eligible entries received.
- 5. Prizes:** Each winner will receive a Full Course Thanksgiving Day Dinner from Williams and Sonoma that will feed up to eight (8) people (this prize may be subject to change/substitution due to availability). The total approximate retail value for each prize, including shipping, is Five Hundred Dollars (\$500.00). Any prize details not specified above will be determined by Sponsor, in its sole discretion. A prize may not be transferred and must be accepted as awarded. Requirements of Potential Winners:** **DUE TO THE SHIPPING DEADLINE, POTENTIAL WINNERS MUST REPLY TO SPONSOR'S EMAIL WITHIN 48-HOURS OF THE DATE OF THE EMAIL TO CLAIM THE PRIZE.** The Winners must agree to how, where and when Sponsor instructs him or her to redeem the prize. Except where prohibited, a potential winner may be required to complete and return an affidavit of eligibility and liability/publicity release. If a potential winner is a minor, his/her parent or legal guardian will be required to sign the documents on his/her behalf. If a potential winner fails to sign and return these documents within the required time period, an alternate potential winner may be selected in his/her place in a random drawing of all remaining entries received. Only three (3) alternate potential winners may be contacted.
- 7. Privacy and Publicity:** Any information you provide when you enter the Sweepstakes will be used in accordance with Sponsor's [Privacy Policy](#). Except where prohibited, participation in the Sweepstakes constitutes your consent to Sponsor's use of your name, likeness, voice, opinions, biographical information, and state of residence for advertising and promotional purposes in in any and all media and in any manners, now or hereafter devised, worldwide in perpetuity, without further payment, consideration or notification to, or permission from you.
- 8. General Conditions:** Participation constitutes entrant's full and unconditional agreement to these "Official Rules," as well as Sponsor's decisions and/or interpretations under these Official Rules, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. In the event that the operation, security, or administration of the Sweepstakes is impaired in any way, Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes; (b) award the prizes at random from among the eligible entries received up to the time of the impairment; or (c) terminate the Sweepstakes. Sponsor reserves the right, in its sole discretion, to disqualify and seek damages from any individual who tampers with the operation of the Sweepstakes, violates these Official Rules, or acts in a disruptive or unsportsmanlike manner. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication. In the event of a dispute as to the owner of an online entry, the authorized account holder of the e-mail address used to enter will be deemed to be the owner. The Sweepstakes is subject to federal, state, and local laws and regulations and is void where prohibited.

9. **Release and Limitations of Liability:** By entering, you agree to release and hold harmless Sponsor, its respective parents, subsidiaries, affiliates, and each of their respective officers, directors, employees, and agents (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Sweepstakes; (b) technical errors; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Sweepstakes or the processing of entries; or (f) injury or damage to persons or property. You further agree that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. You waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.
10. **Disputes:** YOU AGREE THAT ANY AND ALL DISPUTES, CLAIMS, AND CAUSES OF ACTION ARISING OUT OF, OR CONNECTED WITH, THE SWEEPSTAKES, OR ANY PRIZE AWARDED SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION, AND EXCLUSIVELY BY THE APPROPRIATE COURT LOCATED IN TENNESSEE. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of Tennessee, without giving effect to any choice of law or conflict of law rules (whether of Tennessee or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than Tennessee.
